ARTICLE I. IN GENERAL

Sec. 16A-1. Reserved.

Editor's note--Section 16A-1, designating the Charlotte County Regional Planning Council as the local planning agency for the City of Punta Gorda, has been deleted as being superseded by Ord. No. 603-80, enacted Sept. 29, 1980, included herein as Art. II, <sec> 16A-11 et seq. Said <sec> 16A-1 was derived from Ord. No. 477, <sec><sec> 1--4, adopted June 2, 1976.

Sec. 16A-2. Comprehensive land use plan adopted.

The comprehensive land use plan as amended, presented by the Charlotte County-Punta Gorda Planning Council, a copy of which is attached [to Ordinance No. 580-79] and hereby made a part hereof, be and the same hereby is accepted and adopted by the City of Punta Gorda, Florida.

A 1988 comprehensive plan was subsequently adopted by the city via Ord. No. 939-88, adopted Dec. 7, 1988.

Sec. 16A-3. Local planning agency designated.

The City of Punta Gorda Planning Commission created pursuant to the City Charter and Chapter 163 of the Florida Statutes in conformity with the provisions of Section 163.3174, Florida Statutes, is hereby designated and established as the local planning agency for the incorporated area of the City of Punta Gorda, Florida.
